ORDER:

MDM Thalir Children Home under Life Line Trust, No.75&76 B TamilNadu Housing Board, Poolampatti Road, Edappadi Taluk, Salem District Pincode 637101 is registered under section 34(3) of Juvenile Justice (Care and Protection of Children) Act 2000 as amended in 2006 and rules therein vide **SI.No.29/DSD/2014 for one year from the date of issue of Certificate of Registration**. The Conditions under which Registration is issued are:-

1. The Management should run the institution in accordance with Juvenile Justice (Care and Protection of Children) Act, 2000 as amended in 2006.
2. This certificate should be displayed prominently for the information of parents/general public in the office room.
3. The following words may be mentioned in the name board of the Institution. MDM Thalir Children Home under Life Line Trust, No.75&76 B TamilNadu Housing Board, Poolampatti Road, Edappadi Taluk, Salem District **is registered by the Director of Social Defence under Juvenile Justice (Care and Protection of Children) Act 2000 as amended in 2006 and rules therein.**
4. Institution should follow rules / regulations issued by State Government / Director of Social Defence from time to time.
5. The Institution is subject to inspection by the inspection authorities under the Act / Rules and by the persons / officers authorized by the State Government / District Child Protection Society / Child Welfare Committee.
6. Orders should be obtained from Child Welfare Committees for all admissions and Discharges.

7. Any admission / death / repatriation of the children in the institution and any discharge of children from the institution should be intimated to the concerned District Child Protection Officer and Child Welfare Committee.
8. Structural Stability Certificate, Sanitary Certificate, Building License and No Objection Certificate from Fire Service Department should be renewed periodically without fail.
9. The Institution should provide proper infra-structure facilities including sufficient accommodation to children as per ICPS norms.
10. To ensure proper education, child rights and necessary safeguards from child abuses.
10. To provide health facilities, toilet facilities, and bathroom facilities.
11. To ensure water and sanitation and also safe drinking water.
12. Sufficient supervisory and sub – staff should be appointed as per the minimum standards.
13. To maintain the kitchen in a hygienic manner.
14. To follow daily menu chart and ensure both quality and quantity in diet.
15. To arrange recreation and motivation activities.
16. Necessary fire safety facilities should be installed.
17. Rain Water harvesting facilities should be made in the Institute.
18. The Institution should run 500 meters away from the seashore, as a preventive measure from natural calamities.
19. The Institution should remove all Thatched structure if any and replace them by non-flammable material.
20. Required number of fire fighting equipment should be installed and personnel also should be trained in handling them.
